3. **Samples: No added urea-formaldehyde resin particleboard: 12 by 12 inches (300 by 300 mm).**

- c. Credit EQ 4.4 - Low-Emitting Materials: No added urea-formaldehyde resin particleboard manufacturer's product data, indicating no urea-formaldehyde resins are added in the manufacturing process.

2.01 MATERIALS

A. No Added Urea-Formaldehyde Resin Particleboard: VESTA Particleboard manufactured by Flakeboard.

1. Comply with ANSI A208.1, Grade M-2.
2. Certification: Meet CPA 2-06 EPPS including the following:
 - a. Formaldehyde Emission Requirements: ANSI A208.2, Table A and HUD 24 CFR Part 3280.308.
 - b. Recycled Content: 100 percent pre-consumer recycled/recovered wood content.
